Changing Families, Changing Times (Part I)

This panel of experts will examine the impact of the U.S. Supreme Court's decision in *U.S. v. Windsor* (June 2013) on lesbian, gay, bisexual, and transgender (LGBT) people from a national perspective. The panel discussion will highlight common areas of legal concern which judicial officers will be required to consider. Panelists will discuss legal developments since *Windsor*, current policy issues, and practical recommendations (e.g. increased importance and portability of judgments) while analyzing interstate issues, new federal-state legal conflicts, and arguments related to religious exemptions. Part One will explore the effect of *Windsor* on parenting issues (such as definitions of families, reproductive rights and establishing legal ties between parents and children), as well as its effect on divorce and employment.

Of Babies, Bodies and Borders: Emerging Issues in International Surrogacy

This program will explore the legal, social and ethical implications of international child surrogacy arrangements, a rapidly expanding avenue of "contractual childbirth." Some jurisdictions liberally allow commercial surrogacy contracts; some ban them entirely, while others impose extensive regulations. The result is a patchwork of inconsistent laws and a lack of coordinated international regulation. Panelists will discuss the impact of these inconsistent surrogacy laws on the children conceived through surrogacy arrangements, as well as their

birth mothers and intending parents. Panelists will also explore the pros and cons of currently proposed approaches to international coordination, as seen through the lenses of feminist theory, contract theory and children's rights.

Plenary Session: Labor Trafficking

This program is supported by the National Judicial College.

The United States is a destination country for trafficking in persons. Human trafficking is now recognized as a criminal phenomenon that occurs in the vast majority of U.S. communities, with labor trafficking even more prevalent than sex trafficking. Landmark federal legislation — The Trafficking Victims Protection Act of 2000 and its subsequent reauthorizations — enhances criminal penalties, provides civil remedies, and affords new protection to trafficking victims. As of 2014, all 50 states have also enacted state anti-trafficking statutes, which will result in a greater number of state prosecutions as human trafficking task forces and local law enforcement build cases against all forms of trafficking. This session will focus on emerging U.S. trends and legal responses to labor trafficking.

After participating in the session, judges will be able to: (1) Describe how the Trafficking Victim Protection Act of 2000 and later state laws have changed previous definitions of slavery; (2) Define how force, fraud, and coercion are employed against victims in modern human trafficking cases; (3) Identify how labor trafficking is typically manifested in the U.S. economy; and (4) Summarize how federal and state statutes (including California's Transparency in Supply Chains Act of 2010) address the issue of labor trafficking. Join us for a virtual tour of the challenges of criminal justice reform through the eyes of two Mexican lawyers and filmmakers who played a pivotal role in the exoneration of a young Mexican man wrongfully convicted of murder. Other countries in Latin America, as well as the United States, face the similar challenge of wrongful convictions. LAS COLINAS WOMEN'S DETENTION REENTRY FACILITY

Wednesday, October 15th • 9:30AM – 11:30AM

Limited to 30 participants

Please join us for an intimate tour of San Diego County's largest female detention center. The facility is situated on a campus-like setting supporting direct supervision and a "normative environment." You will learn first-hand how San Diego County addresses the age-old problem of high recidivism by offering training and job skills that women will be able to use in securing employment upon their release. Programs offered to the inmates include certifications in food handling, laundry work, culinary baking, sewing and landscaping. Currently, the sewing program produces the majority of clothing provided to the inmates resulting in a large cost savings to the County. We will travel to and from the facility in one of the Sheriff's detention buses, so please arrive by 9:15 am for a 9:30 sharp departure. The guided tour will take place in small groups throughout the expansive grounds and include time for questions and answers. Comfortable shoes and early registration are recommended.

SAN DIEGO INTERNATIONAL BORDER TOUR

Wednesday, October 15th • 10:30AM – 1:30PM

This excursion has three parts: 1) a one-hour walking tour of the Port of Entry, 2) a rolling brief of San Diego Sector Operations from inside the Border Infrastructure System on the east side of the San Ysidro Port, and 3) points of interests on the west side of the San Ysidro Port of Entry.

Attendees will be provided with a narrator who will give a one-hour walking tour of the Port of Entry and answer any questions they might have. They will view primary and secondary pedestrian and vehicle inspection procedures; multi-layered enforcement operations and seizures; watch commander office; canine utilization operations; border technologies: SENTRI primary processing; US-VISIT; License Plate Readers (LPR); Card Readers; Radiation Portal Monitors (RPM); Automated Biometric Identification System (IDENT); Treasury Enforcement Communications System (TECS); Customs Automated System (CAOS); Port Runner Exit Control System; NII Inspection System. They will view Port Enforcement Team (PET) and Anti-terrorism Contraband Enforcement Team (ATCET) operations.

Attendees will enter the Border Infrastructure System (BIS) and be provided with a rolling brief of San Diego Sector Operations. Points of interests on the east side of the San Ysidro Port of Entry will include: view of stadium style lighting; RVSS camera system; All-Weather Rd.; Colonia Libertad; and Soccer Fields.

Points of interests on the west side of the San Ysidro Port of Entry will include: the Revitalization of the Border community near the Tijuana River Channel; tactical border infrastructure and enhancements; W-8; Smuggler's Gluch; Goat Canyon; Border Field State Park. The attendees will visit the Border Field State Park (the most southwestern point of the United States.)

UNACCOMPANIED IMMIGRANT MINOR CHILDREN'S CAMP

Wednesday, October 15th • 12:00PM – 3:00PM

Each year, over 85,000 unaccompanied children enter the United States from countries such as Mexico, Guatemala, and El Salvador. For 2014, it is expected that close to 60,000 will be detected by immigration authorities. These children are often apprehended at international borders and detained by immigration officials, left feeling hopeless and isolated while awaiting immigration court proceedings.

Enter Southwest Key Programs, a national nonprofit organization which operates as the largest provider of services to detained youth. It aims to reunite immigrant children with their families while encouraging the development of personal, social, academic, and vocational skills; working with the Office of Refugee Resettlement (ORR), Southwest Key provides children with opportunities to maximize their potential in the U.S. 2014 NAWJ Conference participants will have the unique opportunity to attend an eye-opening tour of one of two Southwest Key shelters located in San Diego. The rural El Cajon shelter, which tour attendees will have the chance to explore, features a nurturing and therapeutic environment within a three-acre campus for boys ages 12 to 18. Attendees will gain a personal understanding of the Southwest Key shelter mission, and will experience the activities that the camp offers the children, including, outdoor sports, ponies, chickens, roasters, and a fish farm that children assist in caring for, and organic gardening. At the shelter, the youth receive counseling, legal, and medical services, as well as recreation time and an on-site education, all of which tour participants will experience first-hand.

Join us on this unforgettable and interactive tour as we seek to learn more about unaccompanied immigrant youth and the Southwest Key Programs.
